This new water-repellent effect is both economical and environmentally friendly: higher color retention, longer-lasting fabrics and faster drying properties mean lower costs and less pollution.

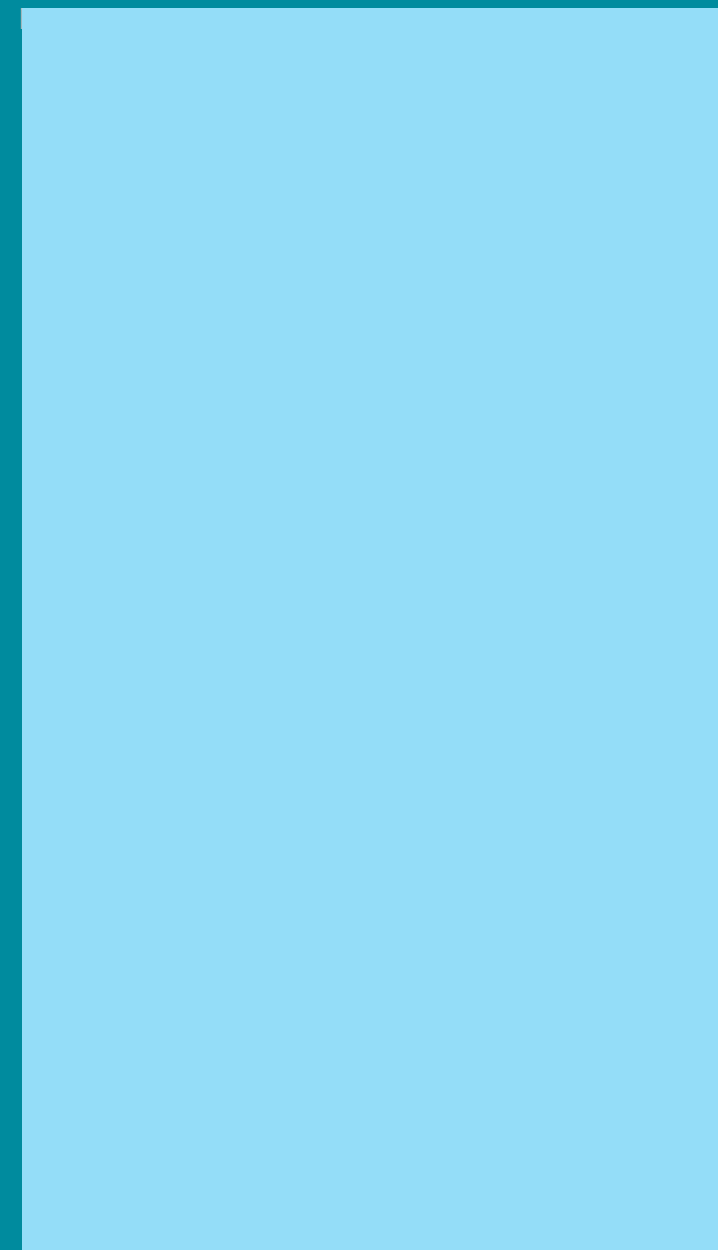
HOW IT WORKS

A repellent finish reduces the surface tension of the textile and prevents liquids from penetrating. The treatment affects neither the appearance nor the breathability of the fabric and leaves it with a soft hand. The lasting properties of this finish, which can withstand up to 30 washes, are achieved with a new innovative hydrophobic system.

- Fabrics: suitable for all fibers and constructions; excellent shade consistency, even with high whites and pastels
- End uses: mainly apparel (e.g. outer wear, leisure wear, bottom weights, casual wear) but also home textiles
